

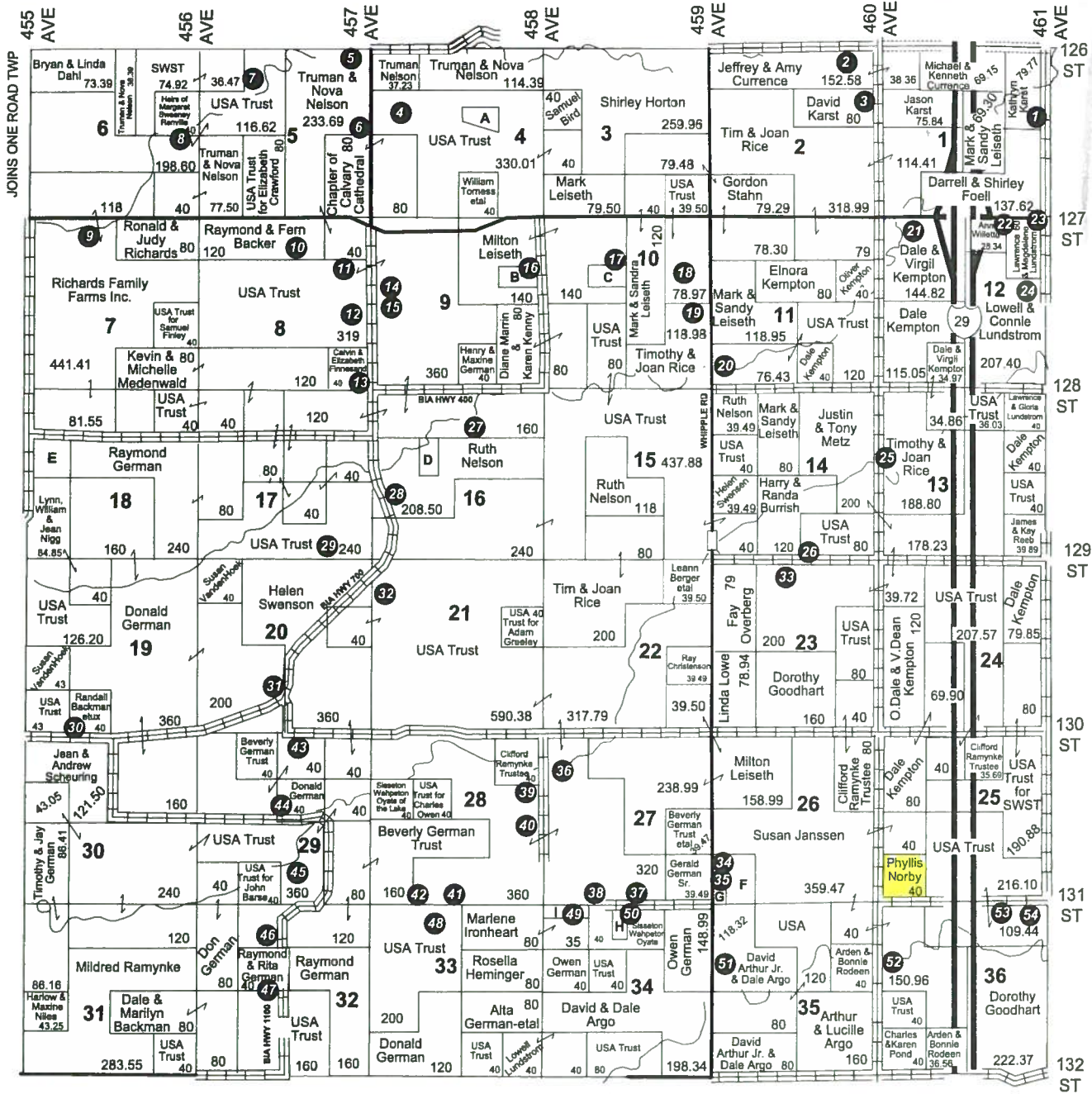

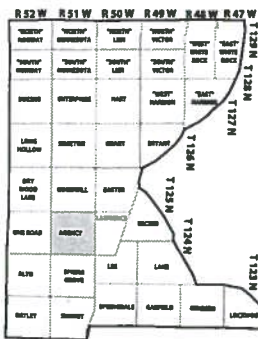
LAND OWNER & RURAL RESIDENT MAPS
